Naval Air Warfare Station

The Naval Air Warfare Station in China Lake, CA receives hundreds of phone calls each day that must be properly fielded and directed. TDEC provides telephone directory assistance and related information, as well as help with external calls including DSN and international.

Centers for Medicare and Medicaid Services (CMS)

TDEC receives thousands of application-related documents submitted under the Affordable Care Act. The CMS requires eligibility to be confirmed and applications processed quickly and effectively. Onsite at one of the CMS locations, TDEC creates accounts and reviews the data for completeness and eligibility. Documents are then processed for approval.

Office of Personnel Management (OPM)

OPM must screen a large volume of security applications each week. Incomplete applications slow processing times and successful adjudications. TDEC provides OPM with administrative services to support personnel security operations in Boyers, PA, processing submissions, identifying incomplete information and conducting follow-up with applicants.

Drug Enforcement Agency

The Drug Enforcement Agency needs timely and accurate investigative information in order to fulfill its mission to combat the production and distribution of illegal drugs. TDEC provides document support services to enter information into agency systems for rapid use by its agents and investigators.

Department of Labor

TDEC staff, located onsite at Department of Labor centers, receive thousands of workers' compensation and other wage-related claims each year. Following standard operating procedures, claims are quickly digitized and validated for processing within 24-48 hours of receipt.

National Institutes of Health (NIH)

The NIH National Heart Lung and Blood Institute wanted to reduce physical file storage space by by converting 1.7M paper records into electronic format and storing in centralized repositories. TDEC scanned the records onsite, and uploaded into shared drives and existing Sharepoint repositories. The result is a highly organized digital repository that can be accessed by NIH users on demand.
